## BETWEEN:

(1) WISDOMTREE COMMODITY SECURITIES LIMITED (formerly ETFS Commodity Securities Limited), a company incorporated under the laws of Jersey with registered number 90959, whose registered office is at Ordnance House, 31 Pier Road, St Helier, Jersey, Channel Islands, JE4 8PW (the "Issuer"); and

THE LAW DEBENTURE TRUST CORPORATION p.l.c., a company incorporated under the laws of England with registered number 1675231, whose registered office is at Fifth Floor, 100 Wood Street, London EC2V 7EX, England (the "Trustee", which expression shall, wherever the context so admits, include such company and all other persons or companies for the time being the trustee or trustees of these presents) as trustee for the Security Holders,
each being a "party" and together the "parties".

## WHEREAS:

(A) The Issuer and the Trustee have entered into a trust instrument dated 21 September 2006 (the "Principal Trust Instrument") as amended by a first Supplemental Trust Instrument dated 17 September 2007, a second Supplemental Trust Instrument dated 23 April 2008, a third Supplemental Trust Instrument dated 15 August 2008, a fourth supplemental trust instrument dated 15 September 2008, a fifth Supplemental Trust Instrument dated 8 October 2008, a sixth Supplemental Trust Instrument dated 29 June 2009, a seventh Supplemental Trust Instrument dated 7 August 2009, an eighth Supplemental Trust Instrument dated 20 January 2011, a ninth Supplemental Trust Instrument dated 14 March 2011, a tenth Supplemental Trust Instrument dated 22 December 2011, an eleventh Supplemental Trust Instrument dated 26 January 2012, a twelfth Supplemental Trust Instrument dated 14 December 2012, a thirteenth Supplemental Trust Instrument dated 23 June 2014, a fourteenth Supplemental Trust Instrument dated 6 October 2014, a fifteenth Supplemental Trust Instrument dated 24 November 2014, a sixteenth Supplemental Trust Instrument dated 3 July 2015, a seventeenth Supplemental Trust Instrument dated 29 June 2017 and an eighteenth Supplemental Trust Instrument dated 31 July 2019 each between the same parties (together the "Trust Instrument").
(B) Pursuant to Clause $33.2(\mathrm{~g})$ of, and paragraphs 19 (a), (b) and (c) and 20 of the Fourth Schedule to, the Principal Trust Instrument, the holders of the Coffee Micro Securities, the WisdomTree Coffee Individual Securities (formerly ETFS Coffee Individual Securities), the WisdomTree Broad Commodities Index Securities (formerly ETFS All Commodities Index Securities), the WisdomTree Agriculture Index Securities (formerly ETFS Agriculture Index Securities), the WisdomTree Softs Index Securities (formerly ETFS Softs Index Securities) and the WisdomTree Broad Commodities Ex-Energy Index Securities (formerly ETFS Ex-Energy Index Securities) have by an Extraordinary Resolution passed on 2 October 2019 (inter alia) sanctioned and consented to the reduction in the Principal Amount of the Coffee Micro Securities from US $\$ 0.00000050$ to US $\$ 0.00000008$, and the reduction accordingly of the Principal Amount of the WisdomTree Coffee Individual Securities, the WisdomTree Broad Commodities Index Securities, the WisdomTree Agriculture Index Securities, the WisdomTree Softs Index Securities and the WisdomTree Broad Commodities Ex-Energy Index Securities to the extent they are comprised of Coffee Micro Securities and sanctioned, authorised, directed and instructed the Trustee to concur in and execute this Supplemental Trust Instrument.
(C) Pursuant to Clause $33.2(\mathrm{~g}$ ) of, and paragraphs 19(a), (b) and (c) and 20 of the Fourth Schedule to, the Principal Trust Instrument, the holders of the Kansas Wheat Micro Securities, the WisdomTree Kansas Wheat Individual Securities (formerly ETFS Kansas Wheat Individual Securities), the WisdomTree Broad Commodities Index Securities, the WisdomTree Agriculture Index Securities, the WisdomTree Grains Index Securities (formerly ETFS Grains Index Securities) and the WisdomTree Broad Commodities ExEnergy Index Securities have by an Extraordinary Resolution passed on 2 October 2019 (inter alia) sanctioned and consented to the reduction in the Principal Amount of the Kansas Wheat Micro Securities from US $\$ 0.00000125$ to US $\$ 0.0000002$, and the reduction accordingly of the Principal Amount of the WisdomTree Kansas Wheat Individual Securities, the WisdomTree Broad Commodities Index Securities, the WisdomTree Agriculture Index Securities, the WisdomTree Grains Index Securities and the WisdomTree Broad Commodities Ex-Energy Index Securities to the extent they are comprised of Kansas Wheat Micro Securities and sanctioned, authorised, directed and instructed the Trustee to concur in and execute this Supplemental Trust Instrument.
(D) Pursuant to Clause $33.2(\mathrm{~g})$ of, and paragraphs 19(a), (b) and (c) and 20 of the Fourth Schedule to, the Principal Trust Instrument, the holders of the Wheat Micro Securities, the WisdomTree Wheat Individual Securities (formerly ETFS Wheat Individual Securities), the WisdomTree Broad Commodities Index Securities, the WisdomTree Agriculture Index Securities, the WisdomTree Grains Index Securities and the WisdomTree Broad Commodities Ex-Energy Index Securities have by an Extraordinary Resolution passed on 2 October 2019 (inter alia) sanctioned and consented to the reduction in the Principal Amount of the Wheat Micro Securities from US $\$ 0.00000025$ to US $\$ 0.00000005$, and the reduction accordingly of the Principal Amount of the WisdomTree Wheat Individual Securities, the WisdomTree Broad Commodities Index Securities, the WisdomTree Agriculture Index Securities, the WisdomTree Grains Index Securities and the WisdomTree Broad Commodities Ex-Energy Index Securities to the extent they are comprised of Wheat Micro Securities and sanctioned, authorised, directed and instructed the Trustee to concur in and execute this Supplemental Trust Instrument.
(E) Pursuant to Clause $33.2(\mathrm{~g})$ of, and paragraphs 19(a), (b) and (c) and 20 of the Fourth Schedule to, the Principal Trust Instrument, the holders of the Sugar Micro Securities, the WisdomTree Sugar Individual Securities, the WisdomTree Broad Commodities Index Securities, the WisdomTree Agriculture Index Securities, the WisdomTree Softs Index Securities and the WisdomTree Broad Commodities Ex-Energy Index Securities have by an Extraordinary Resolution passed on 2 October 2019 (inter alia) sanctioned and consented to the reduction in the Principal Amount of the Sugar Micro Securities from US $\$ 0.00000300$ to US $\$ 0.00000065$, and the reduction accordingly of the Principal Amount of the WisdomTree Sugar Individual Securities, the WisdomTree Broad Commodities Index Securities, the WisdomTree Agriculture Index Securities, the WisdomTree Softs Index Securities and the WisdomTree Broad Commodities Ex-Energy Index Securities to the extent they are comprised of Sugar Micro Securities and sanctioned, authorised, directed and instructed the Trustee to concur in and execute this Supplemental Trust Instrument.
(F) Pursuant to the Trust Instrument, WisdomTree Broad Commodities Ex-Agriculture Index Securities (formerly ETFS Ex-Agriculture Index Securities), WisdomTree Broad Commodities Ex-Grains Index Securities (formerly ETFS Ex-Grains Index Securities), WisdomTree Broad Commodities Ex-Industrial Metals Index Securities (formerly ETFS Ex-Industrial Metals Index Securities), WisdomTree Broad Commodities Ex-Livestock Index Securities (formerly ETFS Ex-Livestock Index Securities), ETFS Ex-Petroleum Index Securities, WisdomTree Broad Commodities Ex-Precious Metals Index Securities (formerly ETFS Ex-Precious Metals Index Securities) and WisdomTree Broad

Commodities Ex-Softs Index Securities (formerly ETFS Ex-Softs Index Securities) are also constituted but none are as at the date of this Supplemental Trust Instrument in issue. Consequent upon the reductions of the Principal Amounts of the Coffee Micro Securities, the Kansas Wheat Micro Securities, the Wheat Micro Securities and the Sugar Micro Securities, the Principal Amounts of the WisdomTree Broad Commodities Ex-Agriculture Index Securities, WisdomTree Broad Commodities Ex-Grains Index Securities, WisdomTree Broad Commodities Ex-Industrial Metals Index Securities, WisdomTree Broad Commodities Ex-Livestock Index Securities, ETFS Ex-Petroleum Index Securities, WisdomTree Broad Commodities Ex-Precious Metals Index Securities and WisdomTree Broad Commodities Ex-Softs Index Securities are also reduced to the extent they are comprised of Coffe Micro Securities, to the extent they are comprised of Kansas Wheat Micro Securities, to the extent they are comprised of Wheat Micro Securities and to the extent they are comprised of Sugar Micro Securities.

NOW THIS SUPPLEMENTAL TRUST INSTRUMENT WITNESSES and it is hereby agreed and declared as follows:

## 1. DEFINITIONS

All words and expressions defined in the Trust Instrument shall unless otherwise stated have the same meanings in this Supplemental Trust Instrument.

## 2. AMENDMENT TO PRINCIPAL AMOUNTS

2.1 The Principal Amount of the Coffee Micro Securities shall be reduced with effect from the date hereof to US $\$ 0.00000008$, the Principal Amount of the Kansas Wheat Micro Securities shall be reduced with effect from the date hereof to US $\$ 0.0000002$, the Principal Amount of the Wheat Micro Securities Micro Securities shall be reduced with effect from the date hereof to US $\$ 0.00000005$ and the Principal Amount of the Sugar Micro Securities Micro Securities shall be reduced with effect from the date hereof to US $\$ 0.00000065$, and:
2.1.1 the tables in the Sixth Schedule of the Trust Instrument shall be amended with effect from the date hereof so that, in Part A of the Sixth Schedule, against "Coffee Micro Securities" there shall be " $\$ 0.00000008$ " and, in Part B of the Sixth Schedule, against "WisdomTree Coffee Individual Securities" there shall be " $\$ 0.08$ ";
2.1.2 the tables in the Sixth Schedule of the Trust Instrument shall be further amended with effect from the date hereof so that, in Part A of the Sixth Schedule, against "Kansas Wheat Micro Securities" there shall be " $\$ 0.0000002$ " and, in Part B of the Sixth Schedule, against "WisdomTree Kansas Wheat Individual Securities" there shall be " $\$ 0.20$ ";
2.1.3 the tables in the Sixth Schedule of the Trust Instrument shall be further amended with effect from the date hereof so that, in Part A of the Sixth Schedule, against "Wheat Micro Securities" there shall be " $\$ 0.00000005$ " and, in Part B of the Sixth Schedule, against "WisdomTree Wheat Individual Securities" there shall be " $\$ 0.05$ ";
2.1.4 the tables in the Sixth Schedule of the Trust Instrument shall be further amended with effect from the date hereof so that, in Part A of the Sixth Schedule, against "Sugar Micro Securities" there shall be " $\$ 0.00000065$ " and, in Part B of the Sixth Schedule, against "WisdomTree Sugar Individual Securities" there shall be " $\$ 0.65$ "; and
2.1.5 the tables in Part C of the Sixth Schedule of the Trust Instrument, which sets out the respective numbers of Micro Classic Securities of each class comprised in, and Principal Amounts of, the Classic Index Securities of each type, shall be read subject to the provisions of sub-clause 2.1.1 to sub-clause 2.1.4 of this clause.
2.2 The definitions of "Classic Index Security", "Classic Individual Security", "Micro Classic Security", and "Principal Amount" in Condition 1.1 of the Conditions of the Micro and Commodity Securities shall be construed subject to clause 2.1 and clause Error! Reference source not found. of this Supplemental Trust Instrument.

## 3. GOVERNING LAW AND SUBMISSION TO JURISDICTION

This Supplemental Trust Instrument shall be governed by and construed in accordance with the laws of Jersey. Each of the parties hereby submit to the non-exclusive jurisdiction of Jersey in respect of any dispute arising out of or in connection with this Supplemental Trust Instrument, including any question regarding its existence, validity or termination, or the legal relationships established by this Supplemental Trust Instrument. Clause 34.2 of the Principal Trust Instrument shall apply to this Supplemental Trust Instrument as it does to the Principal Trust Instrument.

## 4. CONSTRUCTION

4.1 The Trust Instrument shall henceforth be read and construed in conjunction with this Supplemental Trust Instrument.
4.2 A memorandum of this Supplemental Trust Instrument shall be endorsed by the Trustee on the Principal Trust Instrument and by the Issuer on the duplicate thereof.
