Investment Objective

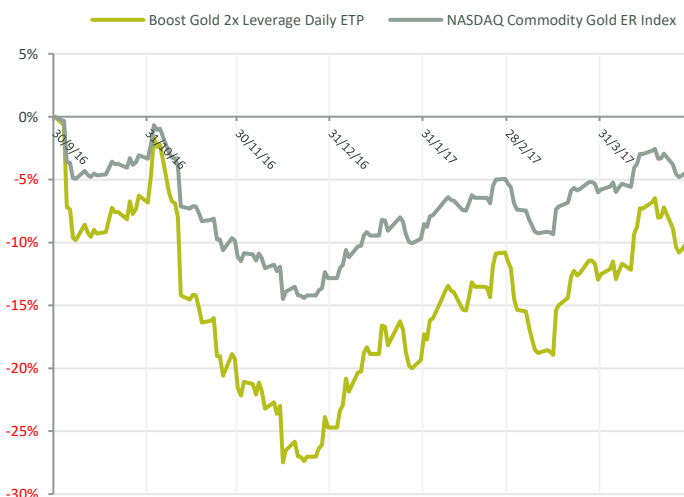
Boost Gold 2x Leverage Daily ETP is a fully collateralised, UCITS eligible ETC. The ETC provides a total return comprised of two times the daily performance of the NASDAQ Commodity Gold ER index, plus the interest revenue earned on the collateralised amount.

For example, if the index rises by 1% over a day, then the ETC will rise by 2%, excluding fees. However if the index falls by 1% over a day, then the ETC will fall by 2%, excluding fees.
