current trends, as well as the flexibility to evolve and face what comes next. A strategy must not only focus on defence, but also factor in key growth areas like the Internet-of-Things and cloud security, as well as be sensitive to security as part of general application development. Expertise is also required to understand the business models of cybersecurity and privacy companies. Some companies have exposure to many different cybersecurity themes, while others are more specialised.

The WisdomTree Team8 Cybersecurity UCITS Index

We focus on the future of cybersecurity. Companies included in the portfolio are chosen for their high exposure to eight themes expected to drive the future growth of cyber-security and must have proven revenue growth capability.

Screening for index inclusion

The index utilizes Focus Score and Growth Score to form the portfolio comprising at least 25 cybersecurity stocks:



Focus score – quantified by each company's perceived exposure across eight cyber development themes. Only companies deemed to have "high exposure" to at least one of the themes are included in the portfolio. These are then classified into "broad focus" and "narrow focus" buckets based on the number of themes they have a high exposure to.



Growth score – quantified by the revenue compound annual growth rate (CAGR) that each company exhibits. Companies must meet minimum CAGR requirements to enter the index and are classified into "Fast Growing", "Growing" and other companies.



ESG Consideration – The index members are also screened for the ESG (Environmental, Social and Corporate Governance) criteria defined within the WisdomTree ESG framework.

Weighting

Weighting leverages companies' Focus & Growth Scores and tilts the portfolio towards the companies with the broadest high exposure to the themes and the fastest revenue growth.
