	Over the course of the inspection, we performed procedures including but not limited to:
	1. Compared the records of the Custodian to the records provided by the Administrator to verify that the palladium bars are held in the name of the applicable account;
	2. Reconciled the total weight of palladium bullion as recorded by the Administrator to the records of the Custodian as at the Audit Reference Date;
	3. Visually checked each bar for the bar number, brand and purity;
	4. Weighed a random sample of palladium bars, equating to approximately 5 percent of the bar list. Bars were weighed in troy ounces to the nearest thousandth of an ounce. Details of each bar weighed were recorded;
	 Reconciled the physical movement of bars which occurred during the inspection period between 31 December 2017 and 2 February 2018.
Anomalies	No anomalies were identified in respect of the palladium bars as at 31 December 2017.

The audit was carried out to the best of our knowledge and this report reflects our findings as at the time and place of the audit only.
