Description of Activity Over the course of the inspection, we performed procedures including but not limited to:

- 1. Compared the records of the Custodian to the records provided by the Administrator to verify that the platinum bars are held in the name of the applicable account;
- Reconciled the total weight of platinum bullion as recorded by the Administrator to the records of the Custodian as at the Audit Reference Date;
- 3. Visually checked each bar for the bar number, brand and purity;
- Weighed a random sample of platinum bars, equating to approximately 5 percent of the bar list. Bars were weighed in troy ounces to the nearest thousandth of an ounce. Details of each bar weighed were recorded;
- 5. Reconciled the physical movement of bars which occurred during the inspection period between 29 May 2015 and 19 June 2015.

Anomalies No anomalies were identified in respect of the platinum bars as at 29 May 2015.

The audit was carried out to the best of our knowledge and this report reflects our findings as at the time and place of the audit only.
