The abovementioned Securities issued by ETFS Metal Securities Limited ("MSL" or "the Company") have been accepted by HM Revenue & Customs into the Reporting Fund regime ("the Reporting Fund Regime") with effect from 1 January 2009. The Company remains a Reporting Fund at the date of this letter.

In order to maintain compliance with the requirements of the Reporting Fund Regime, we are required to report certain information relating to income and distributions for the Securities to Security Holders on an annual basis. This includes a summary of any income which was distributed by the Securities and any excess amounts of income over the amounts actually distributed for each fiscal year.

Pursuant to the MSL prospectus, the Company intends to only hold precious metals in physical form. These precious metal investments do not generate any income required to be disclosed or reported under the Reporting Fund Regime, nor do we anticipate Security Holders will receive income from investment in the Securities.

It is not envisaged that this investment policy will change, and as such reporting for "Amount Actually Distributed" and "Excess of Reporting Income Over Amount Actually Distributed" will show 'Nil' for each fiscal year of the Company.
